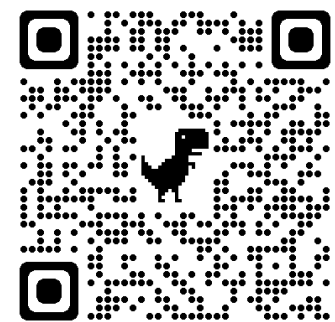

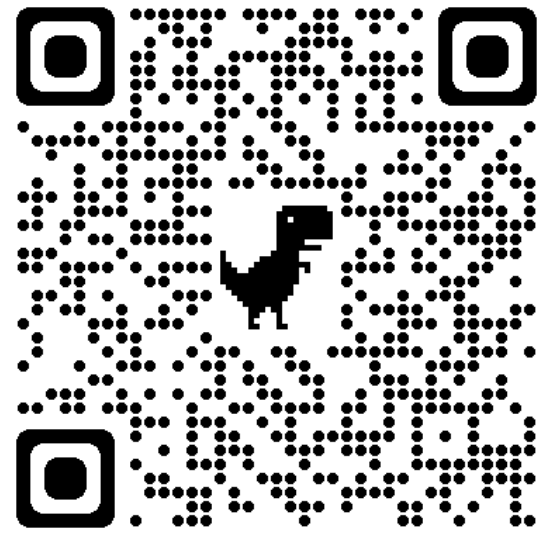

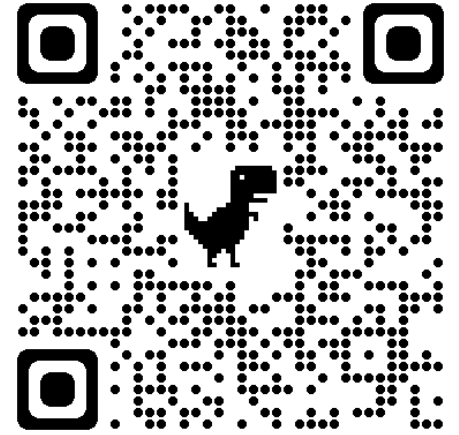

# Family Educational Rights and Privacy Act (FERPA)

- Applies to students age 18 or those enrolled in an institution of higher education.
- What is directory Information?
  - Student's first and last name
  - Major field of study
  - Dates of Attendance
  - Enrollment Status
  - Anticipated graduation date
  - Degrees awarded
  - Awards
- The student has the right to request (in writing) that disclosure of directory information be withheld from persons without a legitimate educational interest.

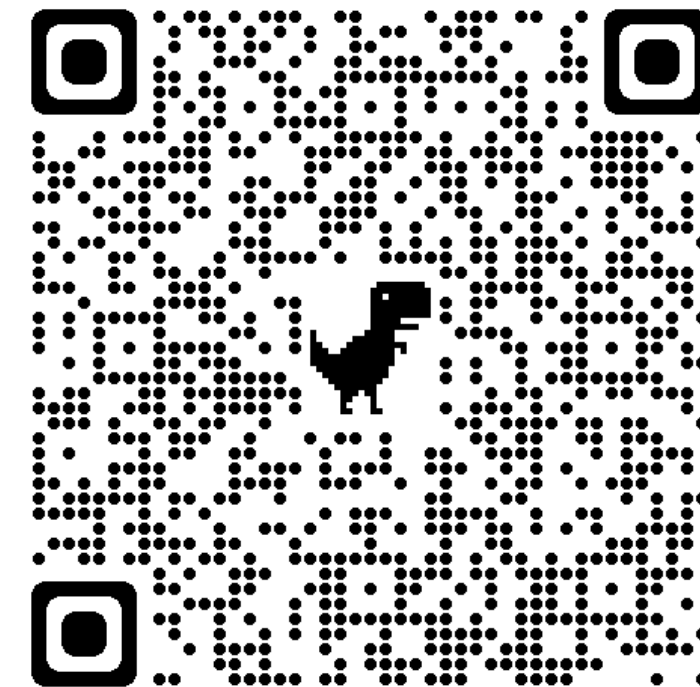
